We are pleased to certify that the audit of account of The Earth Saviours Foundation (Registered office at B-9, Taj Apartment, Ring Road, Near Safdarjung Hospital, New Delhi-29. Presently operating its activities from Bandhwari Village, Gurgaon - Faridabad Road, Near Teri Golf Course, District - Gurgaon, Haryana - 122001) are conducted by us.

The Earth Saviours Foundation is a Gurgaon based NGO registered under societies Registration Act vide Registration No. S/60983/2008 dated 16th January 2008.

The Society is registered under FCRA ( Foreign Contribution Regulation Act.) License registration No. 231661311 dated 02/02/2012 by virtue of which it is receiving foreign donations.

The society is registered under Sec. 12A of the Income Tax Act with the Commissioner Income Tax vide Registration No. T-1208/1391/dated 16/01/2009.

The Society is also registered with the commissioner Income Tax and is entitled to issue certificate to the donors for taking exemption in their hands under Sec. 80G vide Registration No. DEL-TE22596-21042011 dated 21/04/2011.

The NGO meets its expenses solely out of donations received from individuals / corporates / foreign donations.

The Earth Saviours Foundation is also entitled to receive donations / grants / support from corporates / business houses / multinational companies (related organizations ) etc. under the CSR Act. In past and present said NGO has been receiving donations / support from many similar corporate / multinationals and related companies. Specially to support- look after senior citizens.

Since 2008, under the banner of dedicated staff the NGO is running an old age home and a rescue center. Around 275 less privileged people are living full time in the NGO's Gurukul Bandhwari Village, Gurgaon - Faridabad Road, Near Teri Golf Course, District - Gurgaon, Haryana - 122001).



Most of these people are abandoned senior citizens, deprived, mentally disabled, bedridden, HIV infected, patients on death bed, people dying with hunger on roads and patients suffering with incurable disease. By the grace of god all the facilities at the NGO are completely free of charges for less privileged people such as accommodation, food, medical, and every day needs.

These abandoned and disabled people are brought to the NGO center (Gurukul) by Police, Govt. Hospital, referred by Hon'ble courts and by Social Welfare departments.

The other related inter alia objectives of the NGO are as under.

1. To create a sense of belonging, co-operation, mutual harmony, love and affection amongst the members and general public.
2. To promote the cause of National Integration and of India and to fight against the forces of separatism in india.
3. To render services to Women, Children, Youth and Elderly of the country for their annual, moral and social rights.
4. To work for the betterment of slums in rural and urban areas providing excess to safe water and sanitation.
5. To work against the ills prevailing in the society at superstition, hunger and deaths due to starvation, bonded labour, terrorism and other anti social acts.
6. To Provide Legal, Medical, Socio- Economic / Financial and all available means of help / assistance to the poor and needy persons.
7. To help and support people in their pre- retirement stage to prepare for life after retirement. To create a forum for Senior Citizens where they can exchange their views and experiences which could be made available to the younger generation.



8. To provide help and assistance to the physically handicapped individuals.
9. To generate awareness in public about various social issues by using poster, banners, audio- video aids, puppet shows, skits / street plays, documentaries etc.


